# **Primary Objective(s)**

Manager:

The Hot Seat Casework interns and volunteers play a critical role in assisting Amnesty International Australia to respond to requests for assistance and reports of human rights concerns in Australia and overseas.

The Hot Seat role covers a wide range of refugee issues, and receives all incoming requests for assistance from asylum seekers and refugees, particularly those living outside of Australia. The Hot Seat Caseworkers provide assistance to asylum seekers and refuges by making referrals to other organisations for legal, welfare or health related assistance, and monitoring clients on issues of concern.

## Reporting Relationship

This position reports to the Casework Coordinator.

# **The Client Group**

The Hot Seat Caseworkers are part of the Refugee Casework Team, and assists asylum seekers in Australia who are living in the community or Immigration Detention Centres (IDCs). Clients are often highly vulnerable and distressed, with some having experienced torture, trauma and the adverse mental health impacts of long-term detention. Hot Seat also involves working with refugees living overseas and assisting with referrals to UNHCR and in-country social support.

## **Key Responsibilities**

Reporting to the Casework Coordinator, the Hot Seat is responsible for:

• Screening all new phone, email and in-person inquiries from asylum seekers and refugees, their advocates and members of the public.

- Providing appropriate referrals to appropriate legal, mental health, torture and trauma and general welfare services for vulnerable or distressed clients.
- Highlighting issues of concern to the Casework Coordinator
- Contribute to the researching and writing of reports on policy issues, human rights concerns related to clients cases and country information as appropriate.
- Providing administrative support to the Refugee Casework Team by maintaining spreadsheets, supporting intern and volunteer caseworkers to maintain case files and casework processes.
