28 MAY 1961

A MOVEMENT BEGINS Global

On 28 May 1961, British Lawyer Peter Benenson, outraged by injustices he saw, made an appeal to others to unite with him in common action. He saw that by using our rights – our freedom to act for a just world – people can achieve extraordinary things. Together we have offered hope to the oppressed and campaigned for human rights around the world.



1980

LAUNCH OUR FIRST CAMPAIGN AGAINST THE DEATH PENALTY Global

After many years of campaigning, in 2007 the United Nations called for a global moratorium to end the death penalty. When Amnesty International began in 1961, only nine countries had abolished state executions. Today that number has risen to 106, more than half the world's countries.



2004

STOP VIOLENCE AGAINST WOMEN LAUNCH Global

In 2008 the *United Nations Resolution 1820* made sexual violence a war crime against humanity. In 2011 in Australia, the tireless efforts of thousands of supporters and partner organisations resulted in the release of a *National Plan of Action to Reduce Violence Against Women and their Children (2012-2022)* endorsed by Federal, State and Territory Governments.



2014

ARMS TRADE TREATY Global

After 20 years of determined lobbying and campaigning by Amnesty International and partner NGOs, the UN General Assembly voted decisively to adopt the Arms Trade Treaty (ATT). The treaty rules to stop the flow of weapons and munitions to countries where they could be used to commit human rights violations.



2015

AL JAZEERA JOURNALIST FREED Egypt

Australian journalist Peter Greste was convicted for terrorism and spent 400 days in an Egyptian prison, simply for doing his job. Amnesty successfully demanded his release, and we continue to fight for the rights of journalists to do their jobs freely. We'll always speak out for free speech to be respected and protected around the world.



2017

CHELSEA MANNING WALKS FREE USA

In 2013 an American military analyst in Iraq was sentenced to 35 years in prison after releasing information that pointed to potential human rights violations under international law by US forces. Together we sent over 220,000 letters, emails and petitions to President Obama, calling for Chelsea to be released. Your action contributed to her sentence being commuted to time served.



2019

PROTECTING KIDS IN THE JUSTICE SYSTEM Australia

Thanks to the incredible advocacy of our supporters, Queensland Parliament reformed the Youth Justice Act to ensure that children spend as little time as possible in detention centres and harmful police watch houses. It is due to our collective pressure that children are no longer held for prolonged periods of time, with adults or in isolation.



2020

UNCOVERING THE TRUTH China

Amnesty has been collecting testimonies and advocating internationally to help end the persecution of the Uyghur community in Xinjiang in Western China. When graduate student Guligeina Tashimaimaiti disappeared inside a re-education camp after returning from studying overseas, over 20,000 supporters called on China to reveal her whereabouts and release her. Thanks to your determination Guligeina was freed in May 2020.




Organising your Will is a way to ensure that everything you have stood for in your life, everything you believed in and cared so deeply about, lives on for the next generation.
