Our International Issues Committee (IIC) is a Board Committee established to assist and advise the National Board and the organisation about Al Australia's international engagement and contribution. It also advises the Board on changes and developments within Amnesty at an international level.

The IIC consists of the Board Chair, National Director, Global Assembly delegate, Youth Delegate, another Director and three external members (including a designated youth position) who are recruited for their skills and background.

We're looking for a passionate young person (aged between 18 - 25) to join the committee and support the interaction between Amnesty International Australia and the global movement.

As a Committee Member for the International Issues Committee, some of your **main responsibilities** will include:

- Working collaboratively with fellow Committee Members to ensure:
 - the National Board is supported to make informed decisions on international governance issues;
 - the Australian delegation to the Asia Pacific Regional Forum and the Global Assembly are supported;
 - the membership of Amnesty International Australia are informed and engaged on international governance issues.
- Summarising documents into condensed plain English versions.
- Analysing motions and candidature in the lead up to the Global Assembly.
- Attending video conference meetings between 6-8 times per year.
- Preparing for meetings by reading relevant documents and policies.
- Undertaking necessary tasks between meetings.
- Acting as a positive advocate for Amnesty International and upholding our <u>Values and</u> <u>Behaviours Charter and Code of Conduct</u>.
- Helping drive our continued embodiment of our values of Empowerment, Integrity, Persistency and Courage in all of our operational work.

Through this role we are looking to intentionally create a space for young people to be more greatly involved in our organisational governance. This role is a great opportunity for a young person interested in understanding governance and policy processes and frameworks within a major international not-for-profit organisation. We strongly encourage current AIA Members and activists to apply, especially those with qualifications of demonstrable experience in governance and policy.

Selection Criteria & Time Commitment

Expressions of interest are welcome from Al Australia members who are eager to assist with Al Australia's representation and communication at international meetings. The successful applicants will be able to demonstrate an understanding and provide expertise on issues of significance within the international movement, including human rights policy and governance matters.

The commitment for this role is about 1-2 hours per month for a 2-year term with a planned start date of 7 February 2024.
