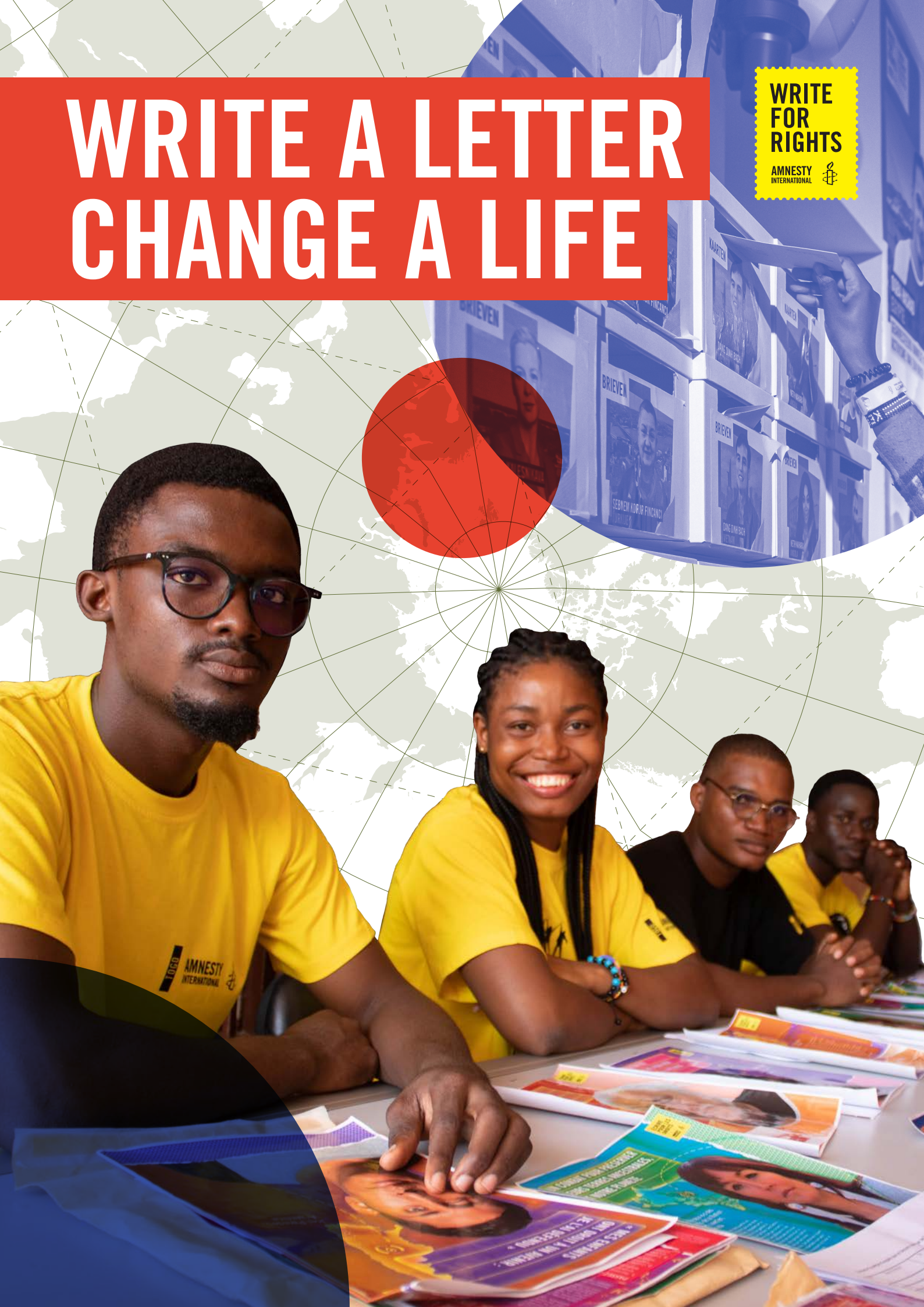


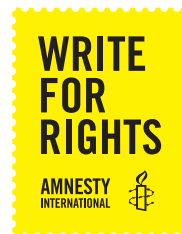

Welcome to Amnesty International's Write for Rights letter-writing kit. Here you will find everything you need to successfully take part in the Write for Rights 2025 campaign.

Write for Rights changes lives and your words matter.

The people featured in this year's campaign are from all around the world. From an Indigenous reindeer herder fighting to protect her community's land in Norway to a photojournalist jailed for reporting on a cyclone in Myanmar, and a little boy who lost his life after falling into a pit toilet at his pre-school in South Africa, all these people are connected because their human rights have been violated.

Amongst others, this year's campaign features people on the front lines of climate change and environmental destruction, fighting to protect their communities from droughts, gas flares, development projects and pollution.

Write for Rights gives you the opportunity to make a real difference to these people's lives. And not just the nine individuals and groups featured in this year's campaign, but the families, communities and networks that surround them.

You're here because you refuse to stay quiet in the face of human rights violations. You want to take action. Whether you do this with a group of friends, classmates, your family or by yourself, the words you write will change lives.

Rocky Myers, a Black man with an intellectual disability, spent three decades on death row in Alabama for murder. Rocky was convicted following testimonies blighted by inconsistencies and alleged police pressure. He was sentenced to death by a judge who imposed a death sentence against the jury's wishes, a practice abolished in Alabama in 2017 but never applied retroactively to Rocky or others like him.

Rocky featured in Write for Rights 2023, leading to huge global campaigning calling for the governor of Alabama to grant him clemency and commute his death sentence. In February 2025, this was granted. Rocky's fight for justice is not over, as his death sentence was commuted to life imprisonment without the possibility of parole, but the threat of the execution has been stopped.

Over two decades ago, a small group of activists in Poland decided to run a 24-hour letter-writing marathon for 10 December – Human Rights Day. The idea took off and today, Write for Rights has grown into the world's biggest human rights campaign.

Every December, supporters across the globe write millions of letters, cards and tweets, and sign petitions supporting people whose basic human rights have been or continue to be attacked.

These supporters form a vibrant community of people like you, continuing a long tradition of writing letters to right some of the world's biggest wrongs.

# WHY DO WE NEED TO TAKE ACTION?



In country after country, people's freedoms to speak out against injustice, to not be discriminated against, to name a few, are under threat. Your letters, words

and actions will put pressure on authorities to take immediate action, so that people's rights are protected and those who abuse people's rights will be brought to justice.

## WHO DO WE WRITE TO?

Every year, we ask supporters to write two types of letters. One is to the person in authority – it could be a president, attorney general or government minister – who can help

make change happen. The other letter is to the person (or group of people) we are fighting for, so they know we are supporting them.





# DOES IT WORK?

Yes! Every year, real change happens because of your letters and actions. People wrongfully imprisoned are released. Abusers are brought to justice. And people in prison are treated more humanely.

# WHEN DOES IT HAPPEN?

Write for Rights centres around Human Rights Day on 10 December but precise dates will vary depending on where in the world you live. Check your local Amnesty website for details.

In September 2020, concerns about the state of Cameroon’s economy led Dorgelesse Nguessan to protest for the first time. During the peaceful demonstrations, Dorgelesse was arrested. She was charged with “insurrection, assembly, meetings and public demonstrations” and sentenced to five years in prison. Following her participation in Write for Rights 2022, in January 2025 Dorgelesse was released and reunited with her family.

## 2 PRINT OUT OUR SPECIALLY DESIGNED STATIONERY

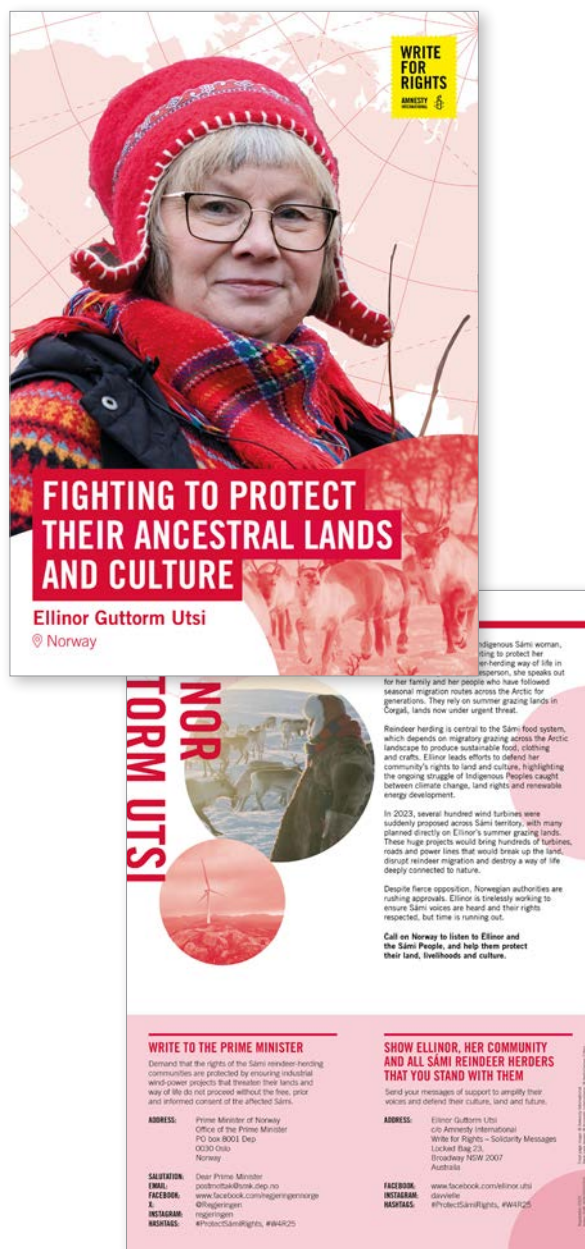
We've created some special stationery which you can download and print. You can use it for any of your Write for Rights letters.

## 3 WRITE YOUR LETTERS

At the back of each information sheet are two addresses.

One is to a government or similar authority: that's the target address. This is the person in authority we are trying to persuade to help the person or people featured. (To make things easier, we've put these addresses on the sample target letters as well: see point 4 for more information.)

The second is for a solidarity letter to the person we want to help, or someone they are close to. This is your chance to write them a personal message of friendship or support. Feel free to draw pictures and be creative.

This kit contains nine sample letters to your target. You can either copy these out in your own handwriting (great!), or rewrite them, adding your own words (even better!).

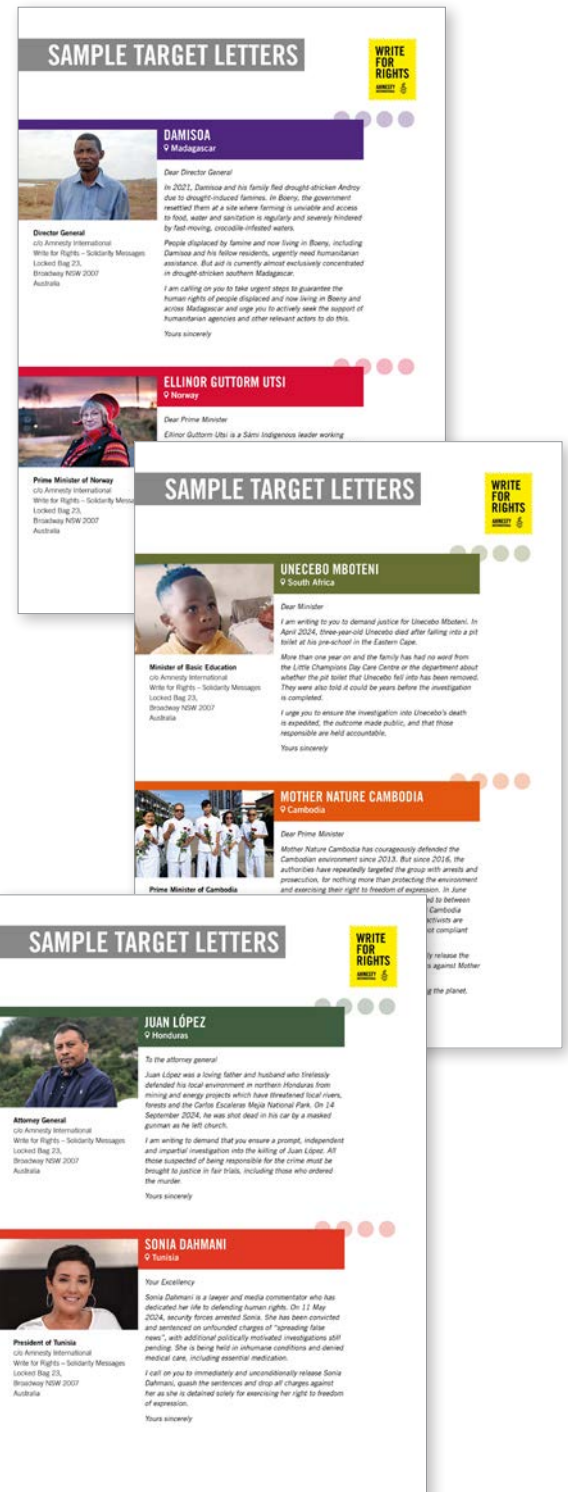
You can write as few or as many as you like.

Through the solidarity he received in 2023, Maung Sawyeddollah felt the embrace of a global community of allies, keeping his hope alive after surviving the Myanmar military's campaign of killings and violence against people from the Rohingya ethnic group. Sawyeddollah was one of the leading activists in his community's pursuit of justice and remediation from Meta Inc., Facebook's parent company, for the company's role in the suffering and displacement of his community. But in 2023, Sawyeddollah faced serious security risks at the refugee camp in Bangladesh because of his human rights work. In August 2024, Sawyeddollah was granted an exit visa from Bangladesh and granted a student visa to attend university in the USA, which is likely to have been made possible because of the huge publicity created by Write for Rights 2023.

## DAMISOA

📍 Madagascar

*Dear Director General*

*In 2021, Damisoa and his family fled drought-stricken Androy due to drought-induced famines. In Boeny, the government resettled them at a site where farming is unviable and access to food, water and sanitation is regularly and severely hindered by fast-moving, crocodile-infested waters.*

*People displaced by famine and now living in Boeny, including Damisoa and his fellow residents, urgently need humanitarian assistance. But aid is currently almost exclusively concentrated in drought-stricken southern Madagascar.*

*I am calling on you to take urgent steps to guarantee the human rights of people displaced and now living in Boeny and across Madagascar and urge you to actively seek the support of humanitarian agencies and other relevant actors to do this.*

## ELLINOR GUTTORM UTSI

📍 Norway

*Dear Prime Minister*

*Ellinor Guttorm Utsi is a Sámi Indigenous leader working tirelessly to protect her community's ancient reindeer-herding way of life in northern Norway. In 2023, several hundred wind turbines were suddenly proposed directly on their summer grazing lands in Čorgaš, threatening to damage grazing land, break migration routes and destroy their culture. Despite fierce opposition, the authorities are rushing approvals.*

*I urge you to protect the rights of the Sámi reindeer-herding communities by ensuring that industrial wind-power projects that threaten their lands and way of life do not proceed without the free, prior and informed consent of the affected Sámi people.*

Dear Minister

*I am writing to you to demand justice for Unecebo Mboteni. In April 2024, three-year-old Unecebo died after falling into a pit toilet at his pre-school in the Eastern Cape.*

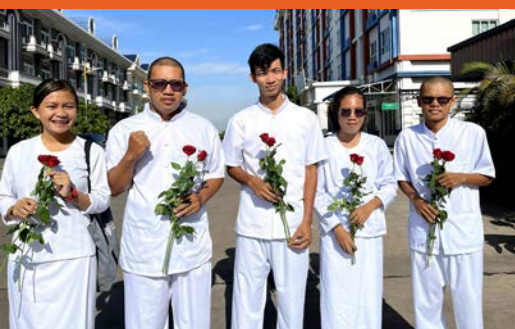
*More than one year on and the family has had no word from the Little Champions Day Care Centre or the department about whether the pit toilet that Unecebo fell into has been removed. They were also told it could be years before the investigation is completed.*

*I urge you to ensure the investigation into Unecebo's death is expedited, the outcome made public, and that those responsible are held accountable.*

## MOTHER NATURE CAMBODIA

📍 Cambodia

Dear Prime Minister

*Mother Nature Cambodia has courageously defended the Cambodian environment since 2013. But since 2016, the authorities have repeatedly targeted the group with arrests and prosecution, for nothing more than protecting the environment and exercising their right to freedom of expression. In June 2024, six members of the group were sentenced to between six and eight years in prison. One member fled Cambodia to continue their work, but the remaining five activists are enduring harsh conditions in prisons that are not compliant with international human rights standards.*

*I call on you to immediately and unconditionally release the five detained activists and quash all convictions against Mother Nature Cambodia activists.*

*Nobody should face prison simply for protecting the planet.*

On 14 September 2024, he was shot dead in his car by a masked gunman as he left church.*

*I am writing to demand that you ensure a prompt, independent and impartial investigation into the killing of Juan López. All those suspected of being responsible for the crime must be brought to justice in fair trials, including those who ordered the murder.*

## GUERRERAS POR LA AMAZONÍA

📍 Ecuador

Dear President

The Guerreras por la Amazonía are fighting alongside the Union of People Affected by Texaco's Oil Operations and the collective "Eliminen los Mecheros, Enciendan la Vida" (Remove the Flares, Ignite Life) to eliminate gas flares which are causing toxic fumes and environmental devastation in their communities. In 2021, a landmark ruling required the government to eliminate the use of gas flares, yet they continue to burn.

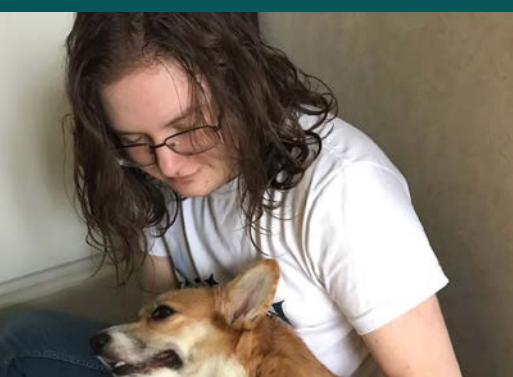
I am deeply concerned that the young defenders are facing stigma and violent intimidation. Rather than investigating the threats against them, the authorities told the group that they will only provide them with protection if they stop their activism.

I demand that you uphold the ruling to eliminate gas flares and ensure the safety of climate defenders.

## MARK KISLITSYN

📍 Russia

Dear Prosecutor General,

In 2022, transgender man and activist Mark Kislitsyn was arrested after peacefully expressing his views online in support of equality and human rights. He was later sentenced to seven years in prison on fabricated charges of "justifying terrorism".

Mark's imprisonment highlights the increasing repression faced by LGBTQI+ people and human rights defenders in Russia. Reports indicate that he has faced harassment and discrimination in detention due to his gender identity and his outspoken activism.

I am calling on you to take urgent steps to guarantee Mark Kislitsyn's immediate and unconditional release. Pending his release, please ensure that he is protected from all forms of discrimination and ill-treatment, and that his rights to safety, dignity and medical care are respected.

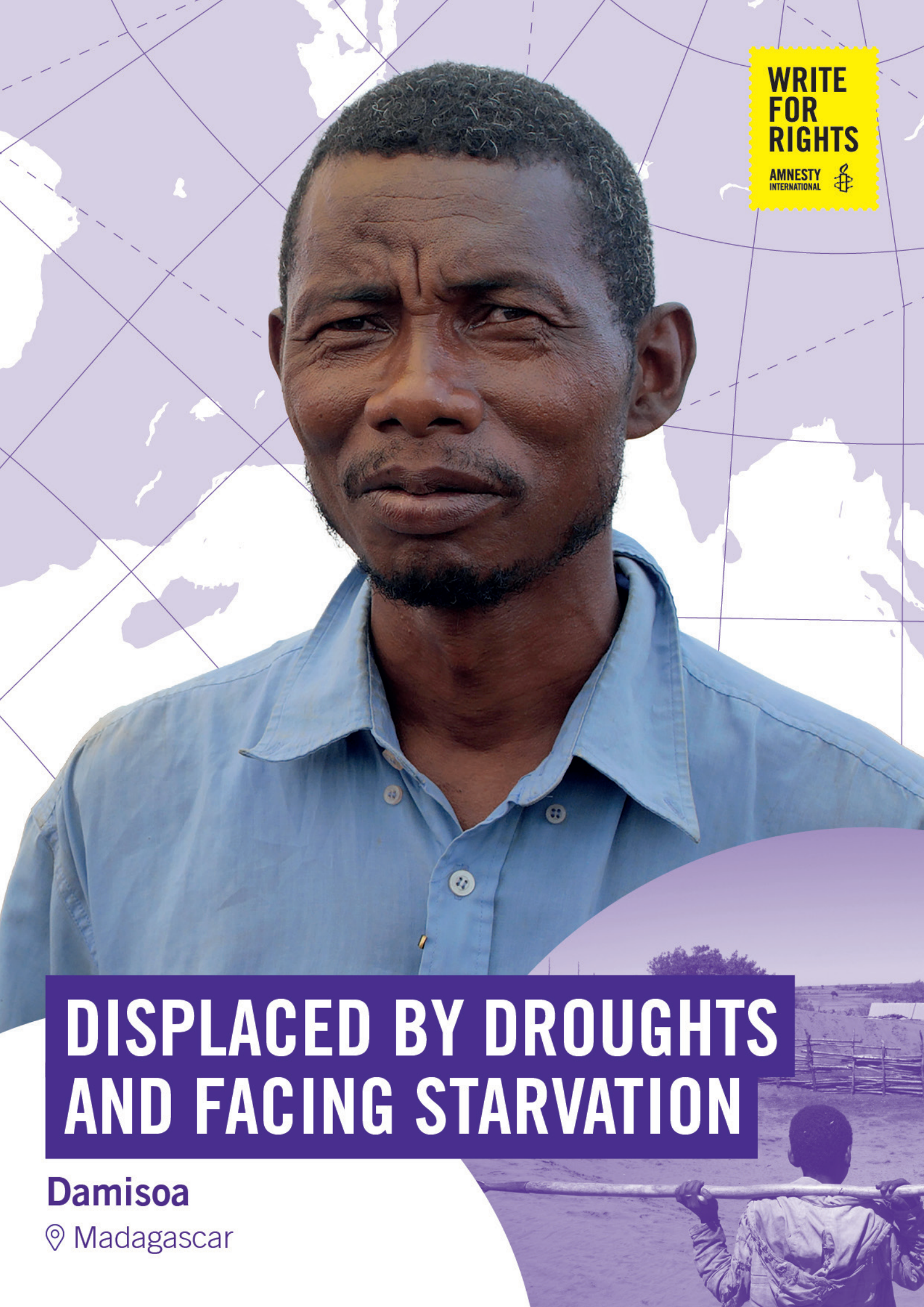

# DISPLACED BY DROUGHTS AND FACING STARVATION

**Damisoa**

📍 Madagascar







## Madagascar



In 2021, Damisoa and his family were forced to leave their home in the Androy region, southern Madagascar. Droughts worsened by climate change meant there wasn't enough food to survive.

After a challenging four-month, 1,500km journey, they reached Boeny in the north-west, hoping for a better life. But conditions remained harsh. In 2023, they were allocated a tiny 5m<sup>2</sup> hut at a resettlement site. Each rainy season the nearby Kamoro River swells, encircling the site with often fast, crocodile-infested waters. This makes it dangerous for residents to leave. The site's land is barren, and access to food, clean water and healthcare is limited. In early 2025, Damisoa's newborn niece died after her mother, weakened by hunger and thirst, could no longer breastfeed. As the government-appointed site manager, Damisoa spends much of his time advocating for the site's residents who are living in degrading conditions. However, his pleas have gone unanswered.

People displaced by famine and now living in Boeny, including Damisoa and his fellow residents, urgently need humanitarian assistance. But aid is currently almost exclusively concentrated in drought-stricken southern Madagascar.

**Demand that the government takes urgent steps to address the hunger, homelessness, poor healthcare and other hardships faced by Damisoa and others displaced by drought across Madagascar.**

## WRITE TO THE DIRECTOR GENERAL OF THE NATIONAL OFFICE OF RISK AND DISASTER MANAGEMENT

Call on the authorities to take urgent steps to guarantee the human rights of people displaced and now living in Boeny and across Madagascar. Ask them to actively seek the support of humanitarian agencies and other relevant actors to do this.

# FIGHTING TO PROTECT THEIR ANCESTRAL LANDS AND CULTURE

**Ellinor Guttorm Utsi**

📍 Norway





Ellinor Guttorm Utsi is an Indigenous Sámi woman, and a passionate leader fighting to protect her community's ancient reindeer-herding way of life in northern Norway. As a spokesperson, she speaks out for her family and her people who have followed seasonal migration routes across the Arctic for generations. They rely on summer grazing lands in Čorgaš, lands now under urgent threat.

Reindeer herding is central to the Sámi food system, which depends on migratory grazing across the Arctic landscape to produce sustainable food, clothing and crafts. Ellinor leads efforts to defend her community's rights to land and culture, highlighting the ongoing struggle of Indigenous Peoples caught between climate change, land rights and renewable energy development.

In 2023, several hundred wind turbines were suddenly proposed across Sámi territory, with many planned directly on Ellinor's summer grazing lands. These huge projects would bring hundreds of turbines, roads and power lines that would break up the land, disrupt reindeer migration and destroy a way of life deeply connected to nature.

Despite fierce opposition, Norwegian authorities are rushing approvals. Ellinor is tirelessly working to ensure Sámi voices are heard and their rights respected, but time is running out.

**Call on Norway to listen to Ellinor and the Sámi People, and help them protect their land, livelihoods and culture.**

Demand that the rights of the Sámi reindeer-herding communities are protected by ensuring industrial wind-power projects that threaten their lands and way of life do not proceed without the free, prior and informed consent of the affected Sámi.

# GUERRERAS POR LA AMAZONIA

Ecuador



*"We are not just activists; we are daughters of the earth, of our communities; we are the warriors of the forest that refuses to die. We are the Amazon that resists the impacts of the oil industry, and for which our communities and our planet are burning."*

The Guerreras por la Amazonía (Warriors for the Amazon) are a group of activists aged 10 to 20 years. They are fighting alongside the Union of People Affected by Texaco's Oil Operations (UDAPT) and the Eliminen los Mecheros, Enciendan la Vida (Remove the Flares, Ignite Life) collective, to protect their communities from the toxic fumes and physical devastation caused by gas flares. Used in the process of extracting oil, gas flares are one of the largest contributors to the climate crisis.

With the support of UDAPT, the Guerreras por la Amazonía joined a lawsuit against the Ecuadorian state in 2020. And won. In 2021, a landmark ruling required the government to eliminate the use of gas flares. Nevertheless, the "fire monsters" continue to burn.

Instead of being celebrated for their bravery, the young defenders face stigma and violent intimidation. Rather than investigating the threats against them, the Ecuadorian authorities told the group that they will only provide them with protection if they stop their activism.

**Call on Ecuador to eliminate gas flares and protect climate defenders.**

# DEFENDER OF RIVERS AND FORESTS MURDERED

Juan López was a loving father and husband. A spiritual leader, he practised his faith by serving his community, always supporting the most vulnerable. He loved chatting with friends over coffee, dancing and spending time by the sea with his family. Friends described him as a dreamer.

Since 2015, Juan tirelessly defended his local environment in northern Honduras from mining and energy projects which have threatened local rivers, forests and the Carlos Escaleras Mejía National Park. Local communities fear that the projects put the surrounding ecosystem and water quality at serious risk.

Juan and fellow activists founded the Tocoa Municipal Committee for the Defence of Common and Public Goods to peacefully challenge the legality of the projects. But their efforts have been met with harassment, threats and criminalization. Many committee members have been arrested and imprisoned. Some have been killed.

On 14 September 2024, Juan was shot dead in his car by a masked gunman as he left church. The alleged shooter and two alleged accomplices have been charged with murder and are being held in pretrial detention. Those who ordered Juan's murder have not been held accountable.

**Demand justice for Juan López.**

Chandaravuth Ly, Keoraksmei Phuon, Kunthea Long, Leanghy Yim, Ratha Sun and Ratha Thun share a love of coffee, books and hiking. Above all, they share a deep love for nature. With their campaign group, Mother Nature Cambodia, they have courageously defended the environment from the harmful actions of companies and the government.

In 2015, the group successfully halted the development of a hydroelectric dam which would have resulted in massive deforestation. In 2016, they were behind a ban on sand exports, protecting coastal areas from environmental degradation.

Their commitment to the environment has inspired young people throughout the country. But their activism has come at a high cost. The authorities have repeatedly targeted the group with arrests and prosecutions. In 2020, three of the activists were arrested for peacefully demonstrating against the infilling of a lake. A year later, three more activists were arrested while investigating the pollution of a river.

In June 2024, the activists were sentenced to between six and eight years in prison. Their crime? Protecting the environment they love so dearly. Ratha Sun fled Cambodia to continue their work, but the remaining five activists are enduring harsh prison conditions.

**Demand that the five detained activists are immediately released and all convictions against Mother Nature Cambodia activists are quashed.**

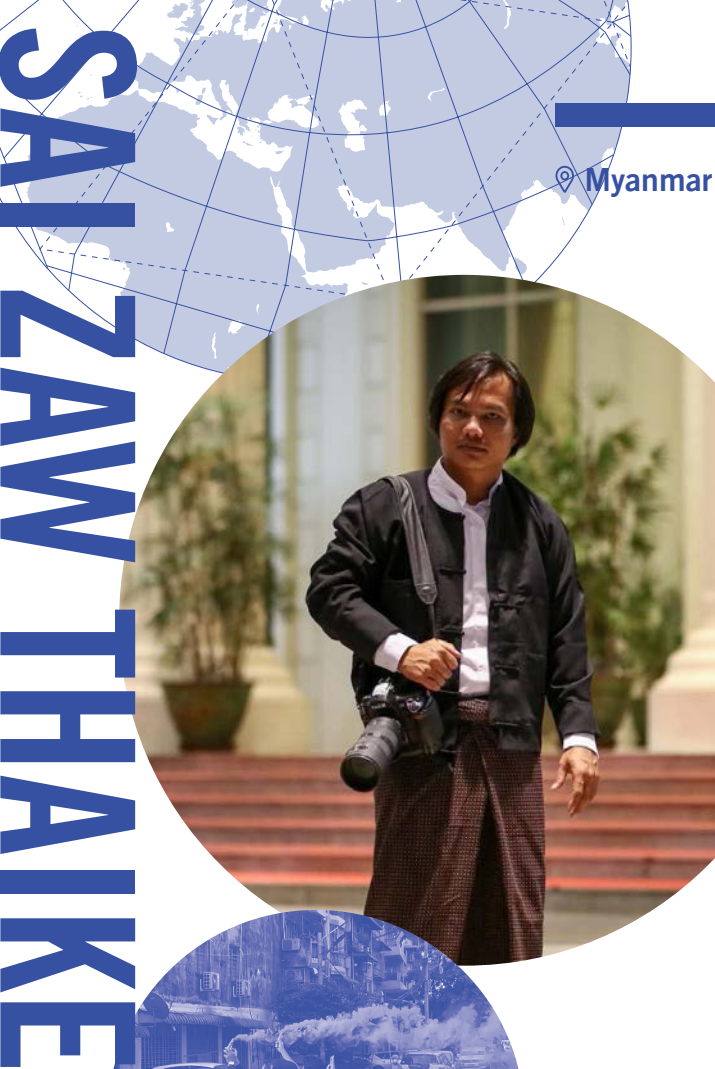


# LOCKED UP AND BEATEN FOR HIS JOURNALISM

Journalism is an extremely dangerous profession in Myanmar. More than 200 journalists have been imprisoned by the military since they took power in 2021. At least seven have reportedly been killed. Media outlets have been banned and forced into exile.

Despite this danger, when Cyclone Mocha slammed into Myanmar in May 2023, photojournalist Sai Zaw Thaike travelled undercover to Rakhine State, determined to report on the devastation.

He embedded himself with a relief team. But after a week there, Sai Zaw was arrested. He was interrogated, beaten and in September 2023, sentenced by a military tribunal to 20 years in prison with hard labour. His trial lasted just one day.

Sai Zaw should be able to report freely. He should also be at home, spending time with his family and doing the things he loves, like playing football, watching Manchester United and seeing friends. He should be caring for his cats who he adores.

Instead, he is locked up. He has endured beatings by prison staff and periods of solitary confinement.

**Demand that Myanmar's military immediately release Sai Zaw Thaike.**

Sonia Dahmani loves the sea, long days at the beach with friends and quiet evenings spent watching movies. She has a deep appreciation for art in all its forms, from paintings and exhibitions to theatre and music. But what matters most to Sonia is her family, including her beloved dog, Carla.

Sonia is a lawyer and media commentator who has dedicated her life to defending human rights, standing up for the marginalized, and saying what others are afraid to, no matter the cost. She is a vocal critic of inhumane prison conditions and racism, regularly addressing these issues on television and radio shows.

On 11 May 2024, masked policemen violently raided the Tunisian Bar Association in Tunis and arrested Sonia. They detained her in Manouba prison, where she has been held ever since. The Tunisian authorities have convicted and sentenced Sonia for “spreading false news”, with more politically motivated investigations still pending. She faces many years in prison for speaking out against injustices. Her imprisonment is a clear attempt to silence her.

Sonia is being held in inhumane conditions. Her cell is rat-infested. She has endured degrading treatment by prison authorities. She is being denied medical care, including the medication she needs.

**Demand Sonia's release now.**

Unecebo Mboteni was a lively three-year-old boy who enjoyed making friends and playing with his toy cars. You could always tell when he was in the room.

On 18 April 2024, Unecebo fell into a pit toilet at his pre-school in the Eastern Cape province of South Africa. He died the next day.

Two other children have also died after falling into pit toilets in the Eastern Cape since 2018. However, the tragic loss of these young lives hasn't been enough to ensure the eradication of all pit toilets in schools, including day care centres. Sadly, a child's experience of education in South Africa still depends on where they are born, their wealth, and the colour of their skin. As Unecebo's father said, "My son died in a death trap set up for poor people."

One year on and the family has had no word from the pre-school or Department of Basic Education about whether the pit toilet that Unecebo fell into has been removed, let alone any progress on the investigation into his death. Instead of answers about how this tragic incident happened, Unecebo's family have been met with silence.

Unecebo lost his life in a place where he should have been safe.

His family deserve answers.

**Demand justice for Unecebo Mboteni.**

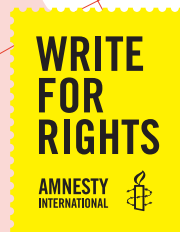
